



CROW CANYON ROAD WIDENING PROJECT

FREQUENTLY ASKED QUESTIONS

1. What is the Project scope?

The Project will construct:

- One additional travel lane in each direction of Crow Canyon Road, between Alcosta Boulevard and St. George Road;
- Improved facilities for pedestrians such as ADA upgrades, crosswalk consolidation, and conversion of sidewalk on the north side into a spacious walking path;
- Installation of widened bike lanes with buffers and green conflict zone striping throughout the Project to provide additional delineation between vehicles and cyclists;
- Installation of new vibrant, drought-tolerant landscaping to enhance the roadway features;
- Updating traffic signals and streetlights, with the latest equipment and technology; and
- Repaving the roadway to provide a new, smooth, and durable roadway surface.

2. What is the remaining Project schedule? (weather permitting)

- Eastbound Estimated Substantial Completion Late Spring/Summer 2024
- Westbound Estimated Substantial Completion Late Summer/Fall 2024
- Construction Completes Fall 2024

3. How much will the Project cost and how is it funded?

DeSilva Gates Construction was awarded the Project with a bid amount of approximately \$12.5M. This road widening work is a requirement of the Dougherty Valley Settlement Agreement and is being funded with Developer funds allocated specifically for this Project.

4. How will the completed Project benefit me as a driver?

- Construction of one additional travel lane in each direction of Crow Canyon Road will create additional roadway capacity.
- Updated traffic signals and streetlights, with the latest equipment and technology, will replace the existing older traffic signals and lighting to provide better traffic signal timing/coordination and improved lighting.
- The roadway will be repaved to provide a new, smooth, and durable roadway surface to remove existing potholes and roadway patches.

5. How will the completed Project benefit me as a bicyclist?

Widened bike lanes with buffers and green conflict zone striping throughout the Project will provide additional delineation and separation between vehicles and cyclists. The roadway will be repaved to provide a new, smooth, and durable roadway surface.

6. How will the completed Project benefit me as a pedestrian?

Improved facilities for pedestrians include ADA curb ramp upgrades, crosswalk consolidation, conversion of sidewalk on the north side into a spacious walking path, and new landscaping.

7. How can I avoid construction on Crow Canyon Road?

During construction, we encourage drivers to use alternate routes such as Dougherty Road, Bollinger Canyon Road, and Alcosta Boulevard for a faster trip. There will be a construction speed limit of 30 MPH enforced along Crow Canyon Road within the construction zone and travel will be restricted to one (1) lane in each direction.
