## The Preserve Project Activities (April - June 2023)

- Lennar has completed construction in Neighborhoods 1 (Highlands), 2 (Foothills) and 3 (Meadows) and Neighborhood 4 (Hillcrest/Ridgeview). Final homes are in the sales process, all others are homeowner occupied.

- ➤ HOA Community Facility/Pool is completed and open for homeowner use.
- Work on the existing and new EBMUD water tanks has been completed.
- Installation of Radar Speed Display Signs has been completed. The final Radar Speed Display Sign, on westbound Faria Preserve Parkway was installed in December 2022.
- Installation of new traffic signal at Faria Preserve Parkway (formerly Purdue Road)/San Ramon Valley Boulevard, and a signal modification at San Ramon Valley Boulevard/Deerwood Road/Fostoria Road are complete.
- Inspection walks for open space landscape areas north and south of Faria Preserve Parkway have begun.
  - West Side Entry Open Space Landscape
    - Landscape has been installed and is currently under evaluation to ensure progressive growth. Re-seeding of slope with wildflower mix is completed.
    - Fence and gate installation at Claremont Crest Way has been completed. Raptor perch requested removal has been completed.
    - Inspection walk has been completed. The City is reviewing that the list of items to be addressed has been completed. The anticipated completion date for the project is June 30, 2023.
- Approximate 12.9 acre Community Park and 0.7 acre Rose Garden construction of underground utilities started in September 2019. Earthwork and above ground concrete work began Summer 2020 and construction is anticipated to be completed by late Spring/early Summer 2023. Please note that the park will remain closed until formal public acceptance is complete through the San Ramon City Council.
- Final inspections for Faria Preserve Parkway are underway and Lennar is in process of turning the roadway improvements over to the City for public acceptance. San Ramon City Council action to accept the roadway improvements is anticipated to take by late Spring/early Summer 2023. The City accepted a portion of Faria Preserve Parkway (Purdue Road Extension) on January 10, 2023.
- ➤ Neighborhood 5 is being developed by Toll Brothers for residential purposes and will include multi-family residences and house of worship. Construction began in April 2021 and includes grading, utility installation, and roadway construction. - The underground utilities and grading for two single-family residential lots on Faria Preserve Parkway at Bollinger Canyon Road have been completed by Lennar. Final development of these properties, including home construction, has been nearly completed by Claremont Homes. Final inspections are currently being conducted by the City.
- ➤ 2.6 acre educational facility property ownership and development is by others. Development plans shall be submitted to the City.
