Notice Inviting Bids

1. Bid Submission. The City of San Ramon ("City") will accept sealed bids for its Pavement Management 2021 Project, CIP Project No. 000003 ("Project"), by or before June 29, 2021, at 2:00 p.m., at the office of the City Clerk, located at 7000 Bollinger Canyon Road, San Ramon, California, at which time the bids will be publicly opened and read aloud.

2. Project Information.

2.1 Location and Description. The Project is located at various streets as shown on the Project Plans, and is described as follows:

The work consists of performing the following, including but not limited to: slurry seal, microsurfacing, and asphalt rubber chip seal pavement treatments; construction signage; pavement striping and markers; and all the other work necessary for a complete project in accordance with the Plans and Specifications, including incidental adjustment of utility covers and manholes to grade, and adjustments of survey monuments frame and covers.

All work shall comply with the Contra Costa County Health Order regarding COVID-19 required procedures. If a Contra Costa County Health Order does not exist then Contractor will comply with State of California requirements for COVID-19 required procedures. Contractor shall be aware that requirements are fluid and may change during the duration of construction; however, the Project must always be in compliance.

- **2.2 Time for Completion.** The Project must be completed within 45 working days from the start date set forth in the Notice to Proceed. City anticipates that the Work will begin on or about August 23, 2021, but the anticipated start date is provided solely for convenience and is neither certain nor binding.
- **2.3 Estimated Cost.** The estimated construction cost for the Base Bid only is \$2.4M.
- 3. License and Registration Requirements.
 - **3.1 License.** This Project requires a valid California contractor's license for the following classification(s): (A) General Engineering Contractor.
 - **3.2 DIR Registration.** City may not accept a Bid Proposal from or enter into the Contract with a bidder, without proof that the bidder is registered with the California Department of Industrial Relations ("DIR") to perform public work pursuant to Labor Code § 1725.5, subject to limited legal exceptions.
- **4. Contract Documents.** The plans, specifications, bid forms and contract documents for the Project, and any addenda thereto ("Contract Documents") may be downloaded from City's website located at: http://www.sanramon.ca.gov/our city/bids r f p. A printed copy of the Contract Documents are not available.
- 5. Bid Security. The Bid Proposal must be accompanied by bid security of ten percent of the maximum bid amount, in the form of a cashier's or certified check made payable to City, or a bid bond executed by a surety licensed to do business in the State of California on the Bid Bond form included with the Contract Documents. The bid security must guarantee that within ten days after City issues the Notice of Potential Award, the successful bidder will execute the Contract and submit the payment, performance, and warranty bonds, insurance certificates and endorsements, and any other submittals required by the Contract Documents and as specified in the Notice of Potential Award.

- 6. Prevailing Wage Requirements.
 - **General.** Pursuant to California Labor Code § 1720 et seq., this Project is subject to the prevailing wage requirements applicable to the locality in which the Work is to be performed for each craft, classification or type of worker needed to perform the Work, including employer payments for health and welfare, pension, vacation, apprenticeship and similar purposes.
 - **Rates.** These prevailing rates are on file with the City and are available online at http://www.dir.ca.gov/DLSR. Each Contractor and Subcontractor must pay no less than the specified rates to all workers employed to work on the Project. The schedule of per diem wages is based upon a working day of eight hours. The rate for holiday and overtime work must be at least time and one-half.
 - **Compliance.** The Contract will be subject to compliance monitoring and enforcement by the DIR, under Labor Code § 1771.4.
- 7. **Performance and Payment Bonds.** The successful bidder will be required to provide performance and payment bonds, each for 100% of the Contract Price, as further specified in the Contract Documents.
- **8. Warranty Bond.** The successful bidder will be required to provide a warranty bond for 15% of the Contract Price, or as otherwise specified in the Contract Documents.
- **9. Substitution of Securities.** Substitution of appropriate securities in lieu of retention amounts from progress payments is permitted under Public Contract Code § 22300.
- 10. Subcontractor List. Each Subcontractor must be registered with the DIR to perform work on public projects. Each bidder must submit a completed Subcontractor List form with its Bid Proposal, including the name, location of the place of business, California contractor license number, DIR registration number, and percentage of the Work to be performed (based on the base bid price) for each Subcontractor that will perform Work or service or fabricate or install Work for the prime contractor in excess of one-half of 1% of the bid price, using the Subcontractor List form included with the Contract Documents.
- 11. Instructions to Bidders. All bidders should carefully review the Instructions to Bidders for more detailed information before submitting a Bid Proposal. The definitions provided in Article 1 of the General Conditions apply to all of the Contract Documents, as defined therein, including this Notice Inviting Bids.
