## **SMALL WIRELESS FACILITIES APPLICATION SUBMITTAL NOTICE**

### **PURPOSE:**

This notice is prepared in accordance with the Council Policy on Small Wireless Facility and Other Infrastructure Deployments Within the Public Right-of-Way, adopted by City Council Resolution No. 2019-87, and posted on the City website and emailed to individuals and entities pre-registered in the Small Cell Notice Registry, to inform the public of the application filing listed below.

### **Project Descriptions:**

Verizon Wireless is requesting an approval to install and operate a new small wireless facility within the public right-of-way of the 2700 block of Bishop Dr. The proposed wireless facility consists of an antenna within a shroud at the top of a new 30-ft. tall pole and a separate array of three antennas near the top of the pole with associated equipment boxes at a minimum of 10-ft. above grade.

### **Action:**

On November 15, 2019, an Application Notice was sent to the applicant informing of the **Incomplete Application** along with a list of required items to be submitted. No action will be taken until the required items are submitted to the City and the application is deemed to be complete. Unless the required items are submitted to the City by January 14, 2020, the application will be deemed withdrawn.
